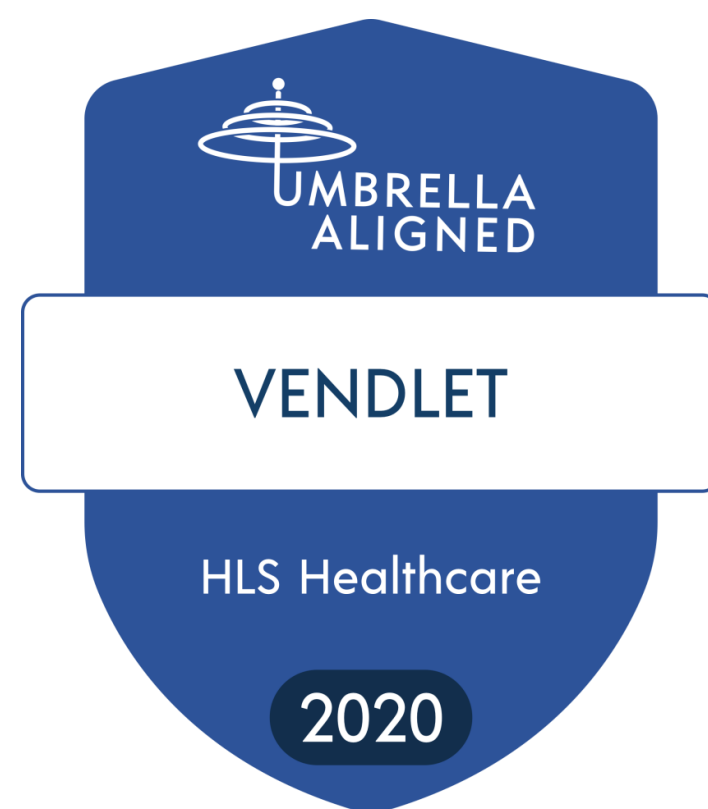

## VENDLET

The VENDLET turning system offers carers effortless resident bed positioning.

With the VENDLET you can position residents easily without needing multiple carers to manually move a resident and risk personal injury. The VENDLET uses two motorised roller bars operated by a handset.

The VENDLET system gives professionals complete control over the repositioning of a resident, without lifting or adjusting the individual's position manually.

When one roller bar turns, it winds the side sheet in, which initiates a highly controlled and comfortable turning motion. Carers can then use their free hand to guide the positioning of the resident.

HLS Healthcare provide the VENDLET V5S for patients up to 200kg and the VENDLET Bari for patients up to 400kg.
